



Membership of the Perth branch now stands at about 125. By far the majority of these members are male and this fact is particularly disturbing to the organizing committee. Attempts are currently being made to rectify this situation. The group has split itself into a number of subcommittees and each of these is run by a convenor who reports back to a monthly meeting. Most of our activity to the present has been in the form of a large Public Meeting, small private discussion groups and Wine and Cheese Evenings.

As in many similar organizations, it is only the willing few who do any of the work and the general apathetic attitudes are certainly not confined to the eastern seaboard. We are seen by many members of Perth's homosexual community as a "lot of shit-stirrers" (even heterosexual Perthites are famed for their lethargy and inactivity!).

The public meeting was a distinct success (far more of the public than of the members). A priest (Roman Catholic), a lawyer, and a psychiatrist were the main speakers and a prominent Perth lawyer Mr. T. McDonnell was the chairman. Press coverage prior to and after the event was satisfactory. (Even the daily newspaper was prepared to have something to say despite an earlier reluctance to accept our paid advertisements).

The Clubrooms sub-committee hopes to achieve some success before Christmas. All members see this as an essential part of our current program and feel that we will not have "arrived" until we secure some permanent headquarters.


Social evenings have been held once per month and have been of mixed success. Overheads and the provision of liquor have contributed to minuscule profits. More rigorous planning will probably be needed before we are able to swell our coffers as will be required when we start on the clubrooms. Kevin, Peter and Margaret have been the key workers on the social side, but they have had few helpers.

On the law reform scene, we have been in contact with particular mem-

bers of the Labor Cabinet but despite the plank in their party's platform regarding law changes, very little has been done. With a new Attorney-General, Mr. D. Evans, it seems as if we will have to start all over again. A petition is being organized and the Canberra draft legislation has been duplicated and sent to senior members of the Government. The Tonkin government has many problems on its hands at the present time and they probably feel that we are an insignificant group. However, through the University branch of the Labor Party, the subject has been discussed at State Executive (despite sniggers from a senior member of the Government) and we are, as always, hopeful if nothing else!

Much more needs to be done to keep the Perth group on its feet. Arthur and Graham spoke to a general meeting of the "Liberation" group some weeks back and there is a real need for much more publicity of this nature.

Members from other states visiting Perth should write in advance and we will endeavour to arrange meetings and possibly accommodation for a short while.

On the 30th Sept. an inaugural general meeting was held by those N.S.W. members who had previously met and decided upon the formation of an A.C.T. branch of CAMP. This meeting was publicized by letter to the Editor of The Canberra Times and by a series of posters placed at strategic positions around Canberra. Elections were held for a governing body of annual appointment. The governing body has moved for the formation of three subsidiary committees:

1) Social Committee.

An immediate problem to be faced is the allocation of a permanent headquarters. Money raising functions are to be arranged to support the rent and maintenance of said quarters as well as the legal activities of the branch.

2) Law Reform Committee.

This is considered to be the most important function of CAMP. The laws dealing with homosexuality and public opinion are the two major concerns of this committee. An alignment between A.C.T. CAMP and the co-founders of the erstwhile Homosexual Law Reform Committee has been carried out. Lobbying for M.P. support against the Draft Criminal Code of the Australian Territories is our immediate goal.

It is hoped that a public forum can be effected on homosexuality in the next six months in Canberra. Specialists shall be invited to speak at the forum i.e. legal, sociology, medical, ecclesiastic etc.

3) Advice and Counsel Committee.

Legal, medical and psychiatric assistance on a referral basis will be instituted as soon as possible.
